WHO IS A MANDATED REPORTER?

A professional or Professional's delegate who is engaged in the practice of the healing arts, social services, hospital administration, psychological treatment, child care, education, law enforcement, and clergy.


WHAT MUST BE REPORTED?

Physical or sexual abuse or neglect of a child **BY CERTAIN PERSONS** when that abuse/neglect has occurred within the past 3 years, or 10 years for multiple victims. OR known or suspected sex trafficking involving a child (17) and under identified as a victim, including alleging sex trafficking by a non-caregiver/ non family unit individual.

Those certain persons are (not necessarily adults):

- A "persons responsible for the child's care"- a person functioning within the family unit with responsibilities similar to a parent or guardian, Or a person outside the family unit with duties of the child's care such as school employees, and other short term caregivers such as baby-sitters, counselors, or coaches.
- A "significant relationship" an immediate or extended family member, or an adult residing in the same home.
- A "position of authority" a person acting in the place of a parent, or having the responsibility for the health, welfare, or supervision of a child, even if briefly. **Minn.Stat.626.556**

MANDATED REPORT: Sexual abuse includes all reports of known or suspected child sex trafficking involving a child who is identified as a victim of sex trafficking. Sexual abuse includes child sex trafficking as defined in section 609.321, subdivisions 7a and 7b.
